

Privacy Statement Nextdoor Interior Design

This Privacy Statement is used by Nextdoor Interior Design, hereinafter referred to as Nextdoor Interior Design.

Via the website www.Nextdoorstyling.com of Nextdoor Interior Design privacy-sensitive data is processed. This information is called personal data. We consider careful handling of personal data of great importance. Personal data are therefore carefully processed and secured by us. Our employees and third parties engaged by us are obliged to respect the confidentiality of your data. Any changes and / or changes to the website may result in changes to this privacy statement.

In our processing we comply with the requirements of the privacy law. That means, among other things, that we:

- clearly state for what purposes we process personal data. We do this via this privacy statement;
- try to limit our collection of personal data to only the personal data needed for the set purposes
- ask you first for explicit permission to process your personal data in cases where your permission is required;
- take appropriate security measures to protect your personal data and also requirements of parties that process personal data on behalf of us;
- respect your right to provide your personal information for inspection, correct or delete

In this privacy statement we explain which personal data we collect and use and for what purpose. We advise you to read this statement carefully.

This privacy statement was last modified on May 1, 2018.

Use of personal data

When using our website, you leave certain information with us. That may be personal data. Personal data are collected by us in different ways. For example, you can submit an application (question) via our website, whereby we ask you to provide us with some personal details in order to answer you.

It is also possible that you approach us with questions and / or complaints by mail, e-mail or telephone. We will contact you in that case to handle the question or complaint.

In addition, data can also be collected via social media channels (such as Facebook, Twitter and Pinterest), for example when you contact us to ask questions. In that case, we only use your account name so that we can respond to your message.

When you use our website, we can process the following data from you:

- Name;
- Address;
- Phone number;
- E-mail address;

The above data is used for the following purposes:

- to communicate with you by sending digital newsletters and / or mail;
- to send you personalized newsletters
- to answer your questions or to handle your complaints via social media, e-mail, by mail or by phone;

Nextdoor Interieur Design collects and processes these Personal Data, which are provided by the visitor / customer at the conclusion of the agreement, permission or justified interest.

Providing these Personal Data for advice is mandatory and a necessary condition to conclude an agreement with Nextdoor Interieur Ontwerp. If this information is not provided Nextdoor Interieur Ontwerp may not be able to fulfill the obligations we have under your agreement or we can not properly enable you to meet your own obligations.

Retention periods

Your data will be retained up to seven years after making a design or giving advice or guidance during renovation for analysis purposes.

Provision to third parties

Nextdoor Interieur Ontwerp will in certain cases, if necessary for the implementation of the purposes included in this Privacy Statement, transfer personal data to third parties.

Purchase agreement:

Mail order company, for delivering your order;

Ateliers, also outside the EEC, for making your customized order;

Upholsterers, for carrying out the work according to the purchase agreement;

Third party executing parties for renovations

Hosting party of the website including the developer;

Furthermore, we will not provide the data you provide to other parties if you have not given permission for this, unless this is legally required or permitted. For example, it is possible that the police will request information from us in the context of fraud investigations. In that case, we are legally obliged to provide this information.

Nextdoor Interior Design does not, in principle, pass on Personal Data to countries outside the European Economic Area or international organizations, unless this is necessary for the execution of the purchase agreement. Should this happen for other reasons, Nextdoor Interieur Design will determine whether there is an adequacy decision within the meaning of the applicable regulations, and if such a decision is not there will only be communication of Personal Data if there are appropriate or suitable safeguards to be. Newsletter

If you have given permission for this, we can send our newsletter by e-mail. With every communication along this route an opt-out option is included if you no longer have interest in our newsletter. You can also report your cancellation to our customer service.

Profiling

We may supplement or optimize your data with data from public sources such as the Land Registry or sources where you have given permission for the use intended by Nextdoor Interieur Design. We only do this when this is legally permitted.

We use cookies when collecting your data. Cookies make it possible, among other things, to show personalized offers from Nextdoor Interieur Design on external websites, ie on websites that are not of Nextdoor Interior Design. We can use cookies to see which advertisements on external websites have been shown to you and whether you have viewed them or not. Want to know more about cookies? Then read our cookie statement.

Accept cookies

I collect data for research in order to gain a better insight into my customers, so that I can tailor the Nextdoor services accordingly. This website makes use of "cookies" (text files placed on your device) to the website to help analyze how users use the site. The through the cookie generated information about your use of the website can be transferred to other secure servers. This information is used to keep track of how you use the website and to prepare reports on website activity.

Logout cookies

Security of personal data

Nextdoor Interieur Design attaches great importance to the security of Personal Data. We are also required by law to ensure the proper security of your Personal Data. For this reason, we have taken the following appropriate technical and organizational measures, including and where appropriate, to protect your Personal Data:

Personal data is pseudonymised and data carriers encrypted;

Setting up authorizations;

Personal data are stored on Nextdoor Interieur Design servers or are adequately secured by suppliers with whom Nextdoor Interieur Ontwerp has concluded a processing agreement;

Processing of Personal Data must be recorded in a register;

It is possible to guarantee the confidentiality, integrity, availability and resilience of the processing systems and services at all times;

Establishing a procedure for testing, assessing and evaluating the effectiveness of the security measures at regular intervals;
It is possible in a physical or technical incident to timely restore the availability of and access to the Personal Data;

SSL

Nextdoor Interieur Design uses certified SSL connections (the Secure Socket Layer - Protocol) for the website during the ordering process and all contact forms. For more information go to secure ordering.
